



## WQSM's "RENDEZVOUS FOR TWO" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQSM, owned and operated by Cumulus Media, 1009 Drayton Road, Fayetteville, NC 28303, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

WQSM will conduct the **Q98 "Rendezvous For Two"** contest (the "contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**
2. **Eligibility.** This Contest is open only to legal U.S. residents' age twenty one (21) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the station in the last 90 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the station in the last 90 days or a prize valued at \$500 or more in the last 180 days. . Void where prohibited by law. Employees of Cumulus Media Holdings Inc., its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
3. **Contest Period.** The Contest will begin at **approximately 3:15 p.m., ET on January 23, 2017** and will run through **approximately 2:00 p.m., ET on February 11, 2017**. WQSM's computer is the official time keeping device for this Contest.
4. **How to Enter.** You will automatically be entered into the Contest once you complete one of the following:
  - (i) **On-Air:** Listen to WQSM, January 22, 2017 through February 10, 2017 on weekdays around 3:15pm., ET. When WQSM plays or gives the "cue to call" listeners should call the station at (910) 864-0698. The correct caller to the station, as determined by the station in its sole discretion, will be qualified to win and win one of the qualifying prizes. **Time Delay between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the WQSM's analog over-the-air signal and WQSM's online webcast, listeners who listen to WQSM online may hear the cue to call later than listeners listening to WQSM's analog over-the-air signal. As a result, the odds of an online listener winning this contest may be diminished.
  - (ii) **Remote Broadcast:** Attend the live remote broadcast conducted by that Station on February 11, 2017, at Biggs Park Mall with Jeff Davis and complete an entry form. **Limit one (1) entry per person per remote broadcast and remain present.** All entries must be received by the 12:00 p.m. (Noon) deadline. Three (3) persons will be chosen at random and be deemed qualifying winners capable of winning the Grand Prize. **YOU MUST BE AND REMAIN PRESENT TO WIN.**
5. **Winner Selection.** One (1) qualifying winner will be selected each weekday during the Contest Period from on-air contesting from Q98. There will be a maximum of fifteen (15) online qualifiers. Each qualifying winner will automatically win , Station Prize Pack valued at no more than \$50. All qualifiers will be invited to the finale at Biggs Park Mall on February 11<sup>th</sup>, 2017 and will automatically be entered into the Rendezvous for Two contest reverse drawing. Qualifiers must present a government issued photo idea, check-in to the event no later than **12:00 p.m. (Noon) on February 11, 2017**, and remain present throughout the event to win the grand prize. Qualifying Winners **may not** send a proxy in his or her place. Any Qualifying Winner not registered by 12:00 p.m. (Noon) will be disqualified and no longer capable of winning the Grand Prize. The eighteen (18) Qualifying Winners will be narrowed down and the Grand Prize winner chosen by reverse raffle using a hopper. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
6. **Grand Prize:** There will be one (1) Grand Prize awarded in this Contest. The grand prize winner will win one (1) voucher for three (3) day /two (2) night hotel accommodations in city of winner's choice. The winner can choose between one (1) of

the locations of the cities of Anaheim, CA, Palm Springs, CA, Las Vegas, NV, Atlantic City, NJ, Branson, MO, Gatlinburg, TN, Daytona, FL, Orlando, FL, Hilton Head, SC, Charleston, SC, Myrtle Beach, SC, and Williamsburg, VA. Winner also receives a Companion Airfare voucher providing two (2) airline tickets for 1 exclusive Guaranteed Lowest Price flight. All expenses and fees associated with the grand prize not expressly included in the foregoing prize description are the sole responsibility of the winner. **Winner and Guest responsible for travel to and from the airport.** Grand prize also includes a Visa credit card in the amount of \$200.00 to help cover hotel accommodation fees, fuel and meal expenses. **ARV \$700.00.** Travel dates to be mutually agreed upon by winner and Station. Winner and guest must travel on the same itinerary. Winner's guest must be eighteen (18) years of age or older. Grand Prize Trip is non-transferable and no substitution will be made except as provided herein at the Station's sole discretion.

**Qualifying Prizes.** Up to Eighteen (18) Qualifying Prizes will be given away in this Contest. Each Qualifying Prize consist of a Station Prize Pack valued at no more than \$50 **ARV of Each Qualifying Prize is \$50**  
Odds of winning one of the Qualifying Prizes and/or the Grand Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time. Station reserves the right to substitute any listed prize for one of equal or greater value for any reason.

7. **Verification of Potential Winner.** POTENTIAL CONTEST WINNER IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner will be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to WQSM, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the Contest Prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.
8. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the WQSM, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Media Inc., and its subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.
9. **Publicity.** Except where prohibited, participation in the Contest constitutes winner's consent to WQSM's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration, unless otherwise prohibited by law.
10. **Taxes.** All State, Local, Federal and or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.
11. **General Conditions.** WQSM reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by WQSM in its sole discretion. WQSM reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, WQSM reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
12. **Limitations of Liability.** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury

or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Contest, provided that if it is not possible to award another entry due to discontinuance or completion of the Contest, or any part of it, for any reason, Station, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In event that production, technical, programming or any other reason causes more than stated number of prizes as set forth in these Official Rules to be available or claimed, WQSM reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

- 13. Disputes.** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, other than those concerning the administration of the Contest or the determination of the winner, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in WQSM's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which WQSM is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which WQSM is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 14. Entrant's Personal Information.** Information collected from entrants is subject to WQSM's Privacy Policy, which is available on the WQSM's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of WQSM to be used, disposed of or destroyed in its sole discretion. WQSM is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to WQSM's website.
