WQSM'S "CARLOS MENCIA" TICKET GIVE AWAY CONTEST OFFICIAL RULES

(the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility.  - (i) On-Air: Listen to the Station Mondays, excluding Federal holidays or any other such Monday as announced by the Station, Between 12:15 pm 1:00 pm and between 3:00 6:00 pm, ET on April 23, 2018 and will run through 6:00 pm., ET on April 27, 2018, during the Contest Period. When the Station plays the "cue to call", listeners should call the Station at 910-864-0981. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be entered to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** On or about 12:15 pm 1:00 pm and 3:00 5:00 pm, on April 27, 2018, Station will select one (1) entry for the Grand Prize in a by calling the Station at 910-864- 0698 when the Station plays the "cue-to-call" will win the Contest. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and

binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
