WQSM "NOW 69" CD GIVE AWAY CONTEST OFFICIAL RULES

Eligibility. Caller eight (8) to the Station as determined by the Station in its sole discretion, will win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast*: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
