WQSM'S "PULL IT FOR POST TICKETS" ON SITE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station insert call letters ("Station"), owned and operated by Cumulus Broadcasting LLC. or one of its subsidiary companies, insert station address, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WQSM's "PULL IT FOR POST TICKETS" ON SITE CONTEST** (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

 - (ii) **Remote Broadcast:** Attend a remote broadcast conducted by that Station and complete an entry form. **Limit one** (1) **entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.
- 5. Winner Selection. On or about 11:01am ET on October 16, 2019 and will run through 1:00pm ET on October 16, 2019 Station will select one (1) entry for the Prize by picking sticky notes off of Jeff Davis on site at Westwood Shopping Center. The winning entrant will be contacted during the remote broadcast and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
